I write following your FOI request dated 10<sup>th</sup> August 2016 in which you request:

Please advise what, if any, transparency requirements you require of the police in your area or that you are planning to require. Please include any transparency requirements for the pay, expenses and allowances for the chief constable and other senior officers.

I then sought further clarification and you informed: Disclosure of financial and performance data and It's really what - if anything the PCC requires of Cleveland Police over and above statutory requirements such as FOI. To give an idea of possible examples this gives the things that local authorities are required to disclose:

You also provided a link for the Local Government Transparency Code 2015 as an example.

This request has been handled under the Freedom of Information Act 2000.

Regarding your request I can now inform you that I have completed my enquiries and that my reply on behalf of the Office of the Police and Crime Commissioner for Cleveland is as follows.

Police & Crime Commissioners have a duty required by statute to publish documents and information as set out in the Elected Local Policing Bodies (Specified Information) Order 2011 and the Elected Local Policing Bodies (Specified Information) (Amendment) Order 2012.
