I will be on leave for the PPOG session on 29 July 2020.

We will need to prepare a written submission which complements whatever the Force propose to present but which also:

- Highlights the ongoing strengthening of the co-working between HMIC and OPCC as national and local scrutineers respectively;
- Shows the approach taken in the 20-21 Police & Crime Plan supplement to holding to account for addressing the Causes of Concern and also the outstanding AFIs.
- Highlights that we have heeded the Chief Constable's request when consulted on the Plan, to mitigate wherever possible the requirements for additional change or CP-led initiatives, whilst emphasis is placed on the Service Improvement Plan
- Draws attention to scrutiny activity in relation to SIP since the last PPOG
- Highlights the work done through the JIAC in relation to assurance on progress with SIP
- Highlights the embeddedness of the Joint Exec Board as a forum for structured joint strategic planning and dialogue.
- Deals in outline with progress by CC and CP overall in relation to the strategic direction.

I'd suggest that this builds on the previous written submissions from Barry to PPOG – which are in Iken 5152.
