Title: Funding - Trans Aware			
Executive Summary: Trans Aware is a charity that operates in Cleveland providing awareness training sessions and workshops to organisations, community and faith groups to raise awareness and understanding towards Transgender and Non-Binary people.			
The charity have requested funding from the PCC to deliver 40 awareness sessions to young people aged 16-17 during their National Citizen Service in August 2017. Funding has also been requested for Trans Aware to deliver an extra 20 sessions for community groups and faith organisations.			
This project supports the PCCs objectives of Working Together to Make Cleveland Safer and Securing the Future of our Communities.			
Decision: To approve £5,000 spend from the Community Safety Initiative Fund for Trans Aware to deliver 40 sessions to groups of young people completing the National Citizen Service and a further 20 sessions for community groups and faith organisations.


