Executive Summary:			
Seeking approval to utilise funding made available from ACPO TAM to upgrade security at above mentioned sites.			
Decision:			
Cleveland SB is required to upgrade the physical security of its offices in order to comply with the latest security requirements for STRAP accreditation.			
Cleveland SB premises were inspected last year for STRAP re-accreditation. The standards have changed in the decade since the previous inspection and several aspects of our physical security are now not up to standard. To maintain STRAP accreditation we must comply with the new standards of physical security. The improvements are compulsory and non-negotiable and are centrally funded by ACPO(TAM).			
The PCC is requested to accept the ACPO TAM Grant and agree to the increase of the revenue budget of the Force by £36,800, from funding to be received, to complete the necessary improvements at Cleveland's SB sites 178 & 25.
